

# **Changes to the Labour Market Report explained**

Date: 17 June 2015

## **Background**

In 2014, the Northern Ireland Statistics and Research Agency (NISRA) held an expert user group meeting and issued a feedback questionnaire in order to obtain feedback and views in relation to the range of labour market statistics produced by Economic and Labour Market Statistics (ELMS).

The feedback from users was generally positive in terms of usage, quality and accessibility of the labour market statistics produced. The key use of the data was to provide economic context in reports for both government and non-government users. The majority of respondents rated labour market statistics in general as 'very useful'.

The consultation found that the most extensively and frequently used labour market statistics were from LFS and claimant count, which were accessed primarily through the Labour Market Report (LMR) and press release. While the majority of users rated the LMR as 'very useful' or 'useful', some improvements were suggested for example, provision of data tables, more historical data and the inclusion of more interpretative commentary in reports.

As a result, the LMR has been reviewed to reflect user feedback, alongside best practice and National Statistics guidance. The revised version of the LMR was published on 17 June 2015 and can be found on the NISRA ELMS website at the following link: <u>Labour Market Report June 2015</u>

# **FREQUENTLY ASKED QUESTIONS**

### How has the LMR changed?

The main changes to the LMR are outlined below:

## Statistical bulletin rather than report style

The report is more succinct, using a consistent format of key points, tables / charts, direct link to data and commentary.

Text is ordered such that key messages are provided at the top of the page with further detail shown at the bottom of the page or overleaf.

Chapters are organised according to labour market theme not labour market source.

Newly published data is highlighted each month.

### • Statistical Press Release

The Statistical Press Release has been summarised to provide headline statistics rather than the same level of detail as the Labour Market Report.

## More interpretative commentary

The report reconsiders the important messages from the statistics each month as opposed to providing a straight update of the figures.

Recent changes are set in context of longer time trends and other official labour market statistics.

#### Background information

The revised Labour Market Report includes links to documents which further explain the sources and supplementary information is provided in the background notes.

## • Interactive data formats

Each table and chart is followed by a link directing the user to the underlying figures in usable format such as Excel.

A summary spreadsheet containing headline statistics from each section accompanies the Labour Market Report, in addition to the more detailed tables per section.

Excel tables are provided in a consistent format without unnecessary columns and rows so that users can easily import data into their preferred programs.

Monthly claimant count data at District Council and Parliamentary Constituency level is added to NINIS interactive maps, with links available from the report.

### Historical data

Longer time series data is included in tables and charts where possible.

Historical data is available on the website, providing LFS statistics back to 1984.

# LMR changes outlined in detail

The LMR now contains 7 sections as follows:

- 1. Summary of Labour Market Statistics
- 2. Unemployment
- 3. Employment
- 4. Economic inactivity
- 5. Earnings
- 6. Further information
- 7. Index of tables

The revised Labour Market Report will be accompanied by an Excel booklet providing the Headline Tables from the LMR, as well as a press release providing a brief summary of the key points.

## What else is new?

The revised Labour Market Report will be accompanied by an Excel booklet providing the Headline Tables from the LMR. This comprises 7 tables in total containing headline figures from the LFS, claimant count, redundancies, QES, ASHE, vacancies and regional summary.
