- similar results available for 2011, areas comparisons





 low Mid Ulster, Fermanagh and Omagh, Lisburn and Castlereagh (2.2%)



Qualifications

- 1 in 3 adults (486,000) had degree level/NVQ 4 or above
- 1 in 4 adults (361,000) had no qualifications
- qualifications level has changed from 2011 to 2021
 - No qualifications fell from 29% to 24%
 - Degree/NVQ 4 rose from 24% to 32% (+150,000 people)



Married or in a civil partnership	693,000	46%
Single (never married or never registered a civil partnership)	571,000	38%
Separated (but still legally married or still legally in a civil partnership)	57,000	4%
Divorced or formerly in a civil partnership which is now legally dissolved	91,000	6%
Widowed or surviving partner from a civil partnership	96,000	6%
Population aged 16 and over	1,515,000	100%

- also asked for first time in Census 2021 in England and Wales





Northern Ireland	2.1%
Wales	3.0%
England	3.2%

Highest LGB+ area in:

England: Brighton & Hove = 10.7%

Wales: Cardiff = 5.3%

Northern Ireland: Belfast = 4.1%

Belfast broadly similar to Liverpool, Leeds, Sheffield
